







Free Early Education Entitlement (FEEE)

At Greystoke Preschool, we are committed to providing high-quality early education to all children.

We offer FEEE, which helps cover the cost of preschool education for eligible children. This funding ensures that every child has access to enriching educational experiences, regardless of their family's financial situation.

Families can apply for funding through their local council, and our team is here to assist you with the application process.

Early Years Funding can significantly reduce the financial burden of childcare, allowing your child to benefit from our nurturing and stimulating environment. This funding ensures that every child can benefit, regardless of their family's financial situation.

Our team is here to assist you in understanding and applying for these funding options, ensuring a smooth and supportive process.

All 3 and 4 year olds - all families	15 free hours per week	over 38 or 51 weeks
All 3 and 4 year olds - eligible working families	30 free hours per week	over 38 or 51 weeks a year



Our Fees

Although government funding is a great way to help with childcare expenses, it only extends to a restricted number of hours and does not cover all costs.

All fees must be paid in advance, monthly, as outlined in the Pre School contract.

We offer support through Early Years Funding, which can help cover the cost of preschool education. Our team is here to assist you in understanding and applying for this funding, making the process as smooth as possible.

Working out the weekly cost

“

My child is eligible for 15 hours a week FEEE and I'd like them to come for 3 hours a day x 5 mornings a week for their *free entitlement only*.

Cost: £0.00

Your child could come from 8.30-11.30am for free Mon-Fri term time only.

Example: families can receive funding all year round if needed by spreading their 30 hours FEEE over 50 weeks, which would equate to 22.8 hours per week of funding.

Stretch funding provides flexibility and ensures that your child can benefit from high-quality early education throughout the year. If you have any questions or need assistance with your specific situation, please do not hesitate to contact our team.

Your Child is eligible for 30 hours per week and you'd like them to attend 5 x full days per week from 07:30 to 18:00.

Cost: £132.00 pw

£5.50 x 3 days for the additional time, plus 2 x days £57.50. You can then use tax free childcare to help cover the remaining amount.



Your child is eligible for 30 hours per week and you would like them to attend from 07:30 to 13:00 5 x days a week

Cost: £0.00

Your child could come for free using 27.5 of their free entitlement and you have 2.5 hours of FEEE remaining.



Workplace Childcare Vouchers

We accept workplace vouchers from the companies listed, to help pay for your child's Preschool fees. If your workplace voucher company is not listed, please contact us and we can register as a user.



Simply allocate an amount to the voucher and the voucher company will send it directly to us.



Additionally, we participate in the Tax-Free Childcare scheme, a government initiative that provides up to £500 every three months (up to £2,000 a year) for each child to help with childcare costs. For children with disabilities, this amount increases to £1,000 every three months (up to £4,000 a year)

Please note: to qualify for these vouchers you must have joined a workplace childcare voucher scheme on or before 4th October 2018.
